# AQYI 2019 IN A SNAPSHOT





### Dear Friends,

#### The year 2019 was a phenomenal one

for the African Queer Youth Initiative. We welcomed three new staff to our management team, and successfully organised our annual general meeting and advocacy training in Mauritius. We trained fifty African LGBT+ youths and provided small grants to support in-country projects targeting LGBT+ youths in Togo, Uganda, Ivory Coast, and Morocco. Our members were present at important conferences and events around the world, speaking truth to power and holding policymakers and adult allies accountable.

Of course, we would not have achieved all these without your support and commitment to the human rights and well being of LGBT+ youth in Africa. However, we have a lot more that needs to be done. In Nigeria, forty seven young gay men have gone on trial on the grounds of homosexuality.

### In Zambia, two young men were unjustly sentenced to fifteen years for engaging in gay sex. In South Africa and Liberia,

there have been reported cases of violence targeting lesbians and peaceful partygoers within the LGBT+ community. Just a few days ago, the South African trans community buried one of their own who was brutally murdered in her home. LGBT+ youths In Africa are not only in a fight for their rights, but also a battle for their lives. They face violence on a daily basis and struggle with homophobic laws bent on erasing their existence, while dealing with poverty. African LGBT+ youths battle a myriad of mental health problems and neglect from family and friends. In many cases, all they have is a community like ours to look up to, and we must not let them down. They need us, they need you. Take a look at the successes we achieved together in 2019 and then imagine what we can do togetherin 2020 and beyond.

### Friedrich Naumann Foundation International Visitors Programme

We learned about the history of the LGBT+ struggle in Germany and got to meet with different LGBT+ organisations and individuals. We even got to interface with a member of parliament who is the current Speaker on Queer Rights for the Free Democratic Party.

We shared about the struggles of young people in Africa.

We were part of the prestigious SOGIE Strategic Litigation and Advocacy Workshop organised by the Centre for Human Rights at the University of Pretoria in South Africa discussing strategies for championing the rights of the African LGBTQI community. We met with members of the team that led the Repeal 162 case, as well as those who led the Botswana Repeal 164 case.

We discussed the different strategies utilized in the cases and how we can best tailor them to the existing legal systems in our individual countries.

Several of our members were also other important spaces such as ICASA; Kvinna TillKvinna convening; and Global Fund Community, Rights, and Gender Advisory Group (CRG - AG).


# TRAININGS

AQYI, in partnership with All-Out, trained twenty-four young activists in a project aimed at contributing to creative, effective, non-violent youth activism for LGBT+ rights in East Africa. The training, tagged Fuelling Digital Activism, also allowed participants the opportunity to launch and run their own digital campaign through a state-of-the-art online activism platform.



## **OPPORTUNITIES**

The AQYI curates a website called Opportunity Point. It is a one stop shop for opportunities for LGBT+ youths in Africa. Opportunities ranging from fellowships and grants to seminars and conferences, etc. are posted regularly for LGBT+ youths to take advantage of. We believe this has helped many young persons to travel and attend events that enhanced their lives and careers.



## GRANTS

We provided grants to four deserving young LGBT+ Africans. In Togo, the grant will be used to organised capacity building geared towards educating LGBT+ Togolese youths on their sexual and reproductive health rights and care as well as on staying safe in homophobic Togo. Our recipient in Uganda will be using their grant to work towards improving healthcare access to members of the Ugandan trans community. In Côte D'Ivoire, similar work will be done with the trans community there. Finally, in Morocco, the grant will go towards research and movement building among Moroccan youths.
